## Miracle Job

#### What was the situation?

September 11, 2015, I was relieved of the position of Director of Financial Aid after being hired six months earlier and worked 14 years at another higher education institution holding the same title.

## What did you do?

In this season of unemployment, I intentionally sought God for comfort and answers with prayer partners and my church community. In December 2015, I became a steady listener of the Winners Call. Each call, I was impressed with the direct godly instructions given by Min. Hazelle.

As instructed, I wrote, posted & meditated on (still, work in progress) scriptures, read some of the recommended books and fasted. During discouraging moments, I would read Jeremiah 29:11, Ephesians 1:17-18, and Romans 12:12 as reminders of God's plan and promise. Each time a rejection appeared to what I believed to be the ideal job; I quickly recalled what Journalist Elizabeth Vargas said during her televised testimonial about her battle with alcoholism, "God says three things: Yes, Not yet, I have something better." In November 2016, Hazelle introduced to the callers "Supernatural Intercessory Prayer Guidelines." These guidelines were my "aha moment." The spirit of burden and frustration lifted. I was empowered! No longer feeling the burden to pray my same "me" prayers. I was relieved & elated to pray for the Kingdom, my church, Winners Call and a host of others.

## What did God do?

January 17, 2017, God blessed me with an offer letter for a part-time position at Apple, Inc. Apple was not on my radar as a potential employer. As a trained financial aid counselor, I only sought employment with higher education institutions. November 2016, one of my many visits to the Apple Store, chatting about life with one of the employees, she shared that I should apply for a position. My immediate response was I don't have the high-level skills... She dismissed my reply and encouraged me to pursue. I did as she instructed with an "I have nothing to lose" attitude.
